Review/Approval of

Minutes: A motion was called to approve meeting minutes of February 18, 2011. Motion carried.

General Update:

Home Energy Auditor RFA

Six (6) organizations have been approved to perform auditor training for the period of 1 year (6/1/2011 through 5/31/2012). Contracts will be issued and processed for full execution and payment at the Comptroller's Office.

Weatherization Specialist RFQ

UWI received forty-nine (49) submissions which are currently under review by our evaluation team.

Grant Contracts/Funding Notification

Mr. Konya provided an update to the Board regarding the Supreme Courts decision surrounding the capital bill and release of funds to grantees. He stated that DCEO will move forward with issuing contracts to UWI awardees. Once the decision has been settled, the Build Illinois Bond Fund (BIBF) will be approved and UWI can move forward.

Ms. Raickett informed the Board that organizations who submitted an RFQ have been kept abreast of changes to the timeline and if necessary, will be notified should additional changes occur.

Area Median Income (AMI)

Representative Winters noted that there is a need for increasing the AMI from 60% to 80%. He suggested that criteria be developed; legislation prepared and ready to submit during Spring session. A shell bill could be approved within 5 weeks. Mr. Konya stated that DCEO will work with Nick Reitz on language to be amended.

UWI Strategic Plan

Ms. Raickett informed the Board that a 5 year strategic plan needs to be developed and implemented. The purpose of the plan is to show UWI's progression to include (skilled training; job development/creation; contractor relationships and benefits to be received by the homeowner).

Percy Harris mentioned that FY10 Census Data has been released and that certain areas of East St. Louis have been impacted by mortgage foreclosures. He stated that he will begin working on a draft of homeowner eligibility guidelines to be implemented. Mr. Konya stated that UWI is continuing to build its infrastructure.
