Digital Equity and Inclusion

Digital Equity: The condition in which individuals and communities have the information technology capacity that is needed for full participation in the society and economy of the United States.

Digital Inclusion: The activities that are necessary to ensure that all individuals have access to and the use of, affordable information and communication technologies such as:

- Reliable broadband
- Devices
- Digital skills training
- Tech support
- Privacy and cybersecurity

When we use the word equity, we accurately acknowledge the systemic barriers that must be dismantled before achieving equitable outcome for all.






Illinois Broadband Team




State Digital Equity Plan Vision

- Ensuring universal access to high-speed broadband that is affordable, reliable, and fully scalable for residences, businesses, and community anchor institutions (CAIs) <u>across Illinois by 2030</u>.
- Leveraging new and existing resources to advance the adoption of internet use through targeted digitalinclusion strategies and sustainable broadband-equity outcomes to help communities identify and address current gaps in broadband equity.
- Empowering all Illinoisans to use and participate fully in an increasingly digital economy and society.




Illinois State Digital Equity Plan

The **2021 Digital Equity Act** provides over \$30 million to Illinois to implement the State Digital Equity Plan (SDEP). The goals of the plan are to ensure that all people and communities have the skills, technology, and capacity needed to reap the full benefits of our digital economy. Core Activities of the SDEP include:




Total amount of funding expected to be awarded is up to \$13,500,000. Awards will range from \$30,000 to \$300,000 on an annual basis, for a three-year term.



National Telecommunications and Information Administration (NTIA)

Requires Prioritization of Covered Populations



80% of Illinoisans are part of these identity groups and communities disproportionally impacted by digital inequity

IDEC Project Types

Digital Literacy and Skill Building	Classes, workshops, coaching, or other learning opportunities to help Covered Populations build digital skills.
Device Distribution	Distribution of devices, including laptops, computers, tablets, or other devices that address barriers faced by Covered Populations.
Digital Navigator(s)	Member of a community trained and designated to help Covered Populations enroll in high-speed internet service, navigate technology challenges, obtain devices, and find digital skill building opportunities.
Computer Center	Establish, improve, or expand community spaces with no-cost access to computers and the internet.
Local Broadband Planning	Resources for communities to create their own roadmaps to expanding broadband connectivity. This includes defining their access goals, assessing market and consumer dynamics, engaging internet providers, and exploring public-private partnerships and funding options.

- Capacity of the Eligible Applicant
- Quality of the Proposal, including Alignment to State Digital Equity Plan
 - Particular Alignment Topics Noted in the Notice of Funding Opportunity (NOFO, page 10) and Program Application
- Support from the Community
- Budget
- Plan for Sustainability

- Additional focused outreach will be conducted following Wave 1 to ensure representation in regions and Covered Populations
- Applications that are not selected in **Wave 1** will carry over to **Wave 2** for evaluation.
- IDEC aims to support programming statewide, with a consideration for geographic diversity and awards made proportional to the regions with high portions of Covered Populations.


Structure of Navigator Program

American Rescue Plan Act

On March 11, 2021, the American Rescue Plan Act (ARPA) was signed into law to provide federal funding to local governments for response and recovery from the COVID-19 pandemic. This funding is in addition to the \$121.5 million in Coronavirus Aid, Relief and Economic Security (CARES) Act funds that Lake County allocated in 2020 to support our residents, communities, taxing districts, businesses, and countywide services in direct response to the COVID-19 pandemic.

ARPA provided \$135.2 million in direct local recovery assistance to Lake County Government. The funding that Lake County received is supporting projects and programs to improve lives, solve problems, and make our County more resilient to future challenges.


The Lake County Board has remained committed to both addressing immediate pandemic response needs and pursuing long-term equity-informed initiatives. Lake County's focus has been to maximize strategic investments that benefit residents for years to come by funding improved outcomes rather than short-term fixes. 



Consider these things when crafting your DN program

- Digital Navigator vs Digital Skills/Literacy Instructor
- Position Description: Clearly defined
- Training/Resources
- Integration into current programming: That's digital inclusion!
- **Employee vs Contracting:** Which will serve your organization AND your clients better?
- New Hire vs Current Staff: Do you need a new staff person, or can you build capacity with current staff?
- Full-Time Employee vs Part-Time Employee: It depends.
- Wages and Benefits
- **Sustainability:** What happens after the funding ends?
- **State Digital Equity Plan Goals:** Will your Digital Navigator Program aligned with Illinois' SDEP goals?


