

**STATE OF ILLINOIS PUBLIC NOTICE**

State of Illinois Disaster Recovery Action Plan Amendment for  
Community Development Block Grant Disaster Recovery (CDBG-DR) Program  
Pursuant to Federal Register Notice FR-5696-N-09.

On June 3, 2014, the U.S. Department of Housing and Urban Development (HUD) announced a supplemental allocation of \$6,800,000 of Community Development Block Grant Disaster Recovery (CDBG-DR) funds to support the State of Illinois continued recovery efforts from disasters occurring in 2011, 2012 and 2013.

Prior to releasing the funds, HUD requires that grantees create an Action Plan Amendment that documents the proposed use of funds, and publish it for public input. HUD approved the State's initial Action Plan prior to release of the June 3, 2013 Federal Register.
