NOTE: The 2024 program has a \$2,500,000 set-aside for investments made into businesses owned by minorities, a \$1,250,000 set aside for investments made into businesses owned by women or persons-with-a-disability, and a \$1,250,000 set aside for investments made into businesses in rural counties. (This includes all Illinois counties aside from Cook, DuPage, Lake, Will, Kane, McHenry, Winnebago, St. Clair and Madison.) The 2023 program had a \$500,000 set-aside for investments made into businesses owned by women, minorities, or persons with disabilities. Another \$500,000 was set aside for investments made into businesses in rural counties.
