The process is subject to the approval of the Carbondale/Murphysboro/Jackson County Enterprise Zone Management Board and the Illinois Department of Commerce and Economic Opportunity. All boundary amendment requests require an application fee of \$500 and applicant may be required to provide surveying data for areas that applicant is requesting to be added to the enterprise zone.
