TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$78.67 billion in 2022. The preliminary agricultural adjusted figure for 2022 is \$82.69 billion; both All Time Highs.^c
- Since 2009, Illinois exports have increased by \$37.05 billion, or 89.0%
- Illinois is the largest exporting state in the Midwest and the 5th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.c
- 19 out of top 20 export industries increased since 2021
- 19 out of top 20 export industries increased since 2009
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Brazil in 2022

- Illinois exports to Brazil totaled \$2.55 billion in 2022, a 104.3% increase since 2009.
- Brazil is Illinois' 6th largest export market
- Illinois ranks 4th among the 50 U.S. states in exports to Brazil
- Illinois imports from Brazil totaled \$2.31 billion in 2022, a 258.9% increase since 2009.
- Brazil is Illinois' 17th largest import market
- Illinois ranks 4th among the 50 U.S. states in imports from Brazil

C: Export statistics are based on Origin of Movement methodology by the Census Bureau which collects information from the Customs and Border Protection from bills of lading. Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commo trading firms maybe the exporter of record even though the products came from a different state/producer.
