#### Exports are a Vital Part of Illinois' Economy<sup>A</sup>

- Preliminary Illinois exports totaled over \$78.67 billion in 2022. The preliminary agricultural adjusted figure for 2022 is \$82.69 billion; both All Time Highs.<sup>c</sup>
- Since 2009, Illinois exports have increased by \$37.05 billion, or 89.0%
- Illinois is the largest exporting state in the Midwest and the 5th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.<sup>c</sup>
- 19 out of top 20 export industries increased since 2021
- 19 out of top 20 export industries increased since 2009
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.<sup>B</sup>

# **Total Trade between Illinois and Gulf Cooperation Council GCC in 2022**

- Illinois exports to the Gulf Cooperation Council GCC totaled \$1.10 billion in 2022, a 57.4% increase since 2009. Top 5 export partners are United Arab Emirates, Saudi Arabia, Qatar, Oman, and Kuwait
- Illinois ranks 12th among the 50 U.S. states in exports to the GCC
- Illinois imports from Gulf Cooperation Council GCC totaled \$578.4 billion in 2022, a 10.2% increase since 2009. Top 5 import partners are United Arab Emirates, Oman, Saudi Arabia, Bahrain, and Qatar
- Illinois ranks 11th among the 50 U.S. states in imports from the GCC

- Gulf Cooperation Council GCC firms employ 735 Illinoisans at 17 distinct locations for 9 subsidiaries
- Gulf Cooperation Council GCC, if a country, would be Illinois' 29th largest FDI partner by employment
