TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$78.17 billion in 2022. The preliminary agricultural adjusted figure for 2022 is \$82.20 billion; both All Time Highs.^c
- Since 2009, Illinois exports have increased by \$36.55 billion, or 87.8%
- Illinois is the largest exporting state in the Midwest and the 5th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.C
- 19 out of top 20 export industries increased since 2021
- 19 out of top 20 export industries increased since 2009
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Japan in 2022

- Illinois exports to Japan totaled \$2.39 billion in 2022, a 34.3% increase since 2009. Japan is Illinois' 8th largest export market
- Illinois ranks 7th among the 50 U.S. states in exports to Japan
- Illinois imports from Japan totaled \$8.92 billion in 2022, a 44.3% increase since 2009. Japan is Illinois' 5th largest import market
- Illinois ranks 4th among the 50 U.S. states in imports from Japan
