TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$78.67 billion in 2022. The preliminary agricultural adjusted figure for 2022 is \$82.69 billion; **both All Time Highs.**^C
- Since 2009, Illinois exports have increased by \$37.05 billion, or 89.0%
- Illinois is the largest exporting state in the Midwest and the 5th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^C
- 19 out of top 20 export industries increased since 2021
- 19 out of top 20 export industries increased since 2009
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Singapore in 2022

- Illinois exports to Singapore totaled \$1.48 billion in 2022, a 68.6% increase since 2009. Singapore is Illinois' 10th largest export market
- Illinois ranks 5th among the 50 U.S. states in exports to Singapore
- Illinois imports from Singapore totaled \$2.49 billion in 2022, a 289.1% increase since 2009. Singapore is Illinois' 15th largest import market
- Illinois ranks 4th among the 50 U.S. states in imports from Singapore

Singaporean Foreign Direct Investment in Illinois^D

- Illinois ranks #2 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,634 foreign firms that employ more than 380,503 Illinois residents
- Singaporean firms employ 2,458 Illinoisans at 36 distinct locations for 14 subsidiaries
- Singapore is Illinois' 22nd largest FDI partner by employment

Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commodity trading firms maybe the exporter of record even though the products came from a different state/producer.
