Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$78.67 billion in 2022. The preliminary agricultural adjusted figure for 2022 is \$82.69 billion; both All Time Highs.^c
- Since 2009, Illinois exports have increased by \$37.05 billion, or 89.0%
- Illinois is the largest exporting state in the Midwest and the 5th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^c
- 19 out of top 20 export industries increased since 2021
- 19 out of top 20 export industries increased since 2009
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

- Illinois exports to South Africa totaled \$686.9 million in 2022, a 26.6% increase since 2009. South Africa is Illinois' 19th largest export market
- Illinois ranks 2nd among the 50 U.S. states in exports to South Africa
- Illinois imports from South Africa totaled \$1.12 billion in 2022, a 44.3% increase since 2009. South Africa is Illinois' 22nd largest import market
- Illinois ranks 3rd among the 50 U.S. states in imports from South Africa
