TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$78.67 billion in 2022. The preliminary agricultural adjusted figure for 2022 is \$82.69 billion; **both All Time Highs.**^C
- Since 2009, Illinois exports have increased by \$37.05 billion, or 89.0%
- Illinois is the largest exporting state in the Midwest and the 5th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^C
- 19 out of top 20 export industries increased since 2021
- 19 out of top 20 export industries increased since 2009
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Sweden in 2022

- Illinois exports to Sweden totaled \$208.5 million in 2022, a 38.5% increase since 2009. Sweden is Illinois' 38th largest export market
- Illinois ranks 10th among the 50 U.S. states in exports to Sweden
- Illinois imports from Sweden totaled \$626.7 million in 2022, a 107.8% increase since 2009. Sweden is Illinois' 30th largest import market
- Illinois ranks 11th among the 50 U.S. states in imports from Sweden

Swedish Foreign Direct Investment in Illinois^D

- Illinois ranks #2 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,634 foreign firms that employ more than 380,503 Illinois residents
- Swedish firms employ 12,962 Illinoisans at 142 distinct locations for 75 subsidiaries
- Sweden is Illinois' 9th largest FDI partner by employment

B: Export Employment Source – DCEO-REMI analysis using data from: Dun and Bradstreet, Census Bureau, NAR, The Trade Partnership via the U.S. Bureau of Economic Analysis and Moody's Analytics data. This statistic will be updated in spring 2024.

C: Export statistics are based on Origin of Movement methodology by the Census Bureau which collects information from the Customs and Border Protection from bills of lading. Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commodity trading firms maybe the exporter of record even though the products came from a different state/producer.

D: Foreign Direct Investment Data Source – Dunn and Bradstreet April 2022 (preliminary) *FDI employment data (domestic) is subject to market fluctuations and data modeling. **L Foreign country employment reporting based on very modeled data and may show regional HQ employment rather than country level
